FIRST ORDER OF BUSINESS

Call to Order/Roll Call

Mr. Adams called the meeting to order at 1:03 p.m. All Supervisors were present.

B. Consideration of Resolution 2024-11, Relating to the Annual Appropriations and Adopting the Budget(s) for the Fiscal Year Beginning October 1, 2024, and Ending

September 30, 2025; Authorizing Budget Amendments; and Providing an Effective Date

Mr. Adams presented Resolution 2024-11. He reviewed the proposed Fiscal Year 2025 budget, highlighting increases, decreases and adjustments, compared to the Fiscal Year 2024 budget, and explained the reasons for any changes. Approximately \$238,000 is budgeted for Field Operations. Revenues are comprised of on-roll assessments and Landowner contributions.

Ms. Lolli asked if the Fiscal Year 2025 on-roll \$728.61 per unit O&M assessment amount includes the cost of collection. Mr. Adams replied affirmatively; the amount shown includes the 4% early pay discount and the 2% and 3% Property Appraiser and Tax Collector fees, respectively.

The Master Association will assume responsibility for maintaining items such as exterior landscape buffer and perimeter walls that they address inside the gates.
